Scheme for FULL & HALF freeship for students of UIT, BU-2019

Basic conditions:-

- 1. Only the poor and meritorious students shall get the benefit of full or half freeship
- 2. The applicant shall pass HS or equivalent exam (10+2 std.) within one year back from the year of admission.
- 3. For the students beneficiaries of the freeship, there will be no consideration for short attendance in any circumstances.
- 4. Benefit of such concession once granted to a candidate in the first year of the course would be continued in the 2 nd, 3rd and 4th year subject to his/her satisfactory progress in the subsequent year(s).
- 5. All the students availing the facility of freeship shall give special services to the Institute as par the demand of the situation (if needed).
- 6. Only the Tuition fee &/or Development fee is to be exempted in full or half, to the eligible candidates.
- 7. Candidates seeking such concession in tuition fee would be required to submit application in prescribed format to the principal along with the income certificate of guardians from appropriate authority. The committee formed for this purpose will select the names of the eligible candidates.
- 8. Candidates receiving any other scholarship may not be considered if there is any other deserving candidate, if not then the amount of freeship should be reduced by the amount of scholarship already received.

Eligibility criteria:

For Full Freeship

1. Should get at least 60% marks in 10th and at least 60% each in Physics, Chemistry and Mathematics in 12th standard exam / holding a rank in JEE upto 5000/500/200 in general/SC/ST category respectively & got admission through WBJEE counseling.

2. Total family income per annum should not be more than Rs.2,50,000/-

3. If he / she fail to perform satisfactorily in any semester exam he will be allowed to get the benefit once during the entire course only after getting special permission from Hon'ble VC. 4. Domiciled in State of West Bengal

For Half Freeship

1. Should get at least 60% marks in 10th and at least 60% each in Physics, Chemistry and Mathematics in 12th standard exam / holding a rank in JEE upto 5000/500/200 in general/SC/ST category respectively & got admission trough WBJEE counselling.

2. Total family income per annum should not be more than Rs. 2,50,000/-

3. If he / she fail to perform satisfactorily in any semester exam he will be allowed to get the benefit once during the entire course only after getting special permission from Hon'ble VC. 4. Domiciled in State of West Bengal

* Mere fulfillment of the above criteria does not automatically make the candidate entitled for the freeship. Definition of few terms:

1. Short attendance: Below 75% of all classes without considering medical or other considerable grounds. Below 65% of total classes after considering medical and other considerable grounds. 2. Appropriate authority: BDO/ SDO/DM/Govt. Official designated to issue such certificate

3. Satisfactory performance: Passing in original chances with at least 50% marks in each subject.
